#### **Business Litigation**

Defended investment advisory firm and individual investment advisors in breach of fiduciary duty matter which, after week-long arbitration hearing, ended in complete defense victory and order that plaintiff pay all defense costs and attorney fees.

Litigated \$200 million fraud case on behalf of mining client defendant to successful resolution in which plaintiffs consented to judgment entering against them.

On behalf of controlling owners, successfully defended derivative action in business divorce case, then sued minority owner on behalf of company, obtained preliminary injunction, and entered into favorable settlement.

In adversary proceeding in bankruptcy court, on behalf of Colorado-based investment company that owned a multi-million-dollar loan, on which the debtor had successfully evaded liability for a decade, litigated the case to favorable settlement within one year of being hired as counsel.

#### **Trade Secrets and Non-Competes**

As defense counsel for departing employee, defeated motion for TRO in trade secrets/covenant-not-to-compete case, in which plaintiff then voluntarily dismissed the action and entered into settlement when served with a motion for sanctions.

Litigated trade secrets and non-solicitation case against former employees and their new business, settling favorably before trial.

Represented emerging growth company in non-circumvention arbitration, successfully employing strategy to have the arbitration stayed by state trial court.

#### **Commercial Real Estate Litigation**
