- Sole arbitrator in multi-million dollar AAA arbitration brought by limited liability company members to determine rightful ownership of LLC interests in resort. Claims involved fraudulent inducement, breach of fiduciary duty, breach of operating agreement, expulsion and dissociation under the Wyoming LLC Act.
- Wing arbitrator in AAA arbitration involving financing of the design and development of cultivation and processing facility for medical cannabis. Claims involved breach of contract, breach of implied covenant of good faith and fair dealing, and appointment of a receiver. Counterclaims were brought for breach of contract and fraudulent inducement.
